- h) Funds drawn are not parked in any Bank Account outside the State account.
- i) Procurement shall be made as per actual requirement through a transparent system of e-tendering as per the extent of rules/ codal formalities keeping the latest specifications of the equipments / items into consideration, with no compromise on the quality and reasonability of the rates.
- j) Expenditure incurred against the funds released during the current financial year shall be intimated to this Department/ office by or before 25th of each month together with progress report.
