Terms of Reference:-

- (i) The Committee shall continuously monitor the availability of medical oxygen in the Union territory of Jammu & Kashmir and report any shortfalls/related problems immediately to the Central Control Room established in the Ministry of Health and Family Welfare (MoHFW), Government of India.



- (ii) The Committee shall ensure that no restrictions are imposed on the movement of medical oxygen into the Union territory and free inter-State movement of oxygen carrying vehicles is permitted.
- (iii) The Committee shall ensure that no restrictions are imposed on oxygen manufacturers and suppliers to limit the oxygen supplies only to the hospitals of the UT.
- (iv) The Committee shall ensure free movement of oxygen carrying vehicles into the cities, irrespective of timings, alongwith inter-city supply without restriction.
