Terms of Reference:-

To prepare an Action Plan for tackling a possible third wave of COVID-19 pandemic in the Union territory of Jammu and Kashmir with special focus on:

- (i) Preparedness in terms of creation of health infrastructure, enhancement in testing capacities, treatment protocols, arrangement of essential drugs/logistics, Machinery and Equipments, oxygen supply, manpower, etc.
- (ii) Ramping up COVID hospital beds and Critical Care Units especially for Pediatrics/Neo-natal age group, which is likely to be affected more.
- (iii) Strengthening of Healthcare/COVID Care facilities in the rural areas of the Union Territory.



- (iv) Devising additional COVID appropriate behavior and SOPs/guidelines that are required.


