Sub: Restrictions for COVID containment - regarding

Government Order No. 73 -JK (DMRRR) of 2021

Dated: 22 .10.2021

1) Whereas, a detailed review of the current COVID situation in Jammu and Kashmir was held by the Chief Secretary, J&K, with the ACS Finance, ACS (Health and Medical Education), Principal Secretary (Home), Principal Secretary (PWD – R&B), Divisional Commissioners, Deputy Commissioners, Superintendents of Police and other officers of Jammu and Kashmir on 16.10.2021; and

2) Whereas, it was observed that there is a need to continue with the existing COVID containment measures in all districts in view of the uneven trend observed daily COVID cases.

3) Now therefore, the State Executive Committee, in exercise of the powers conferred upon it under section 24 of the Disaster Management Act, 2005, hereby orders that the guidelines / instructions on COVID containment in the Union Territory of Jammu and Kashmir, already notified vide Government Orders 35 and 36 - JK (DMRRR) of 2021 dated 29-05-2021 read with Government Order 72 - JK (DMRRR) of 2021 dated 17-10-2021, shall continue to remain in force till further orders.

4) On the basis of the assessment, the State Executive Committee, in exercise of the powers conferred up on it under section 24 of the Disaster Management Act, 2005, hereby orders the following –

The number of Yatri to Mata Vaishno Devi Ji Shrine may be regulated taking into account the following: -

- i. Strict adherence to Covid Appropriate Behaviour/SOP must be followed.
- ii. Valid and verifiable RT-PCR/Rapid Antigen Test of Yatri not older than 72 hours of arrival should be made mandatory.
- iii. Only those Yatri shall be allowed to visit the Mata Vaishno Devi Ji Shrine who do not show any Covid related symptoms.

- iv. Premises of Mata Vaishno Devi Ji Shrine should be properly sanitized as per the Covid Standard Operating Procedures (SOP).


